<u>Audit Standard:</u> Education & Training

Deadline to Complete Corrective Action: October 2, 2025

Corrective Action:

U.S. Bowling Congress must create a written protocol to ensure that the organization offers training for parents and minor athletes regarding the prevention and reporting of child abuse annually, at least every 12 months.

Status: Completed before the deadline

Corrective Action Remediation Date: September 18, 2025

Audit Standard: Communication & Reporting

Deadline to Complete Corrective Action: October 31, 2025

Corrective Action:

U.S. Bowling Congress must demonstrate at another event:

- a. Communication of the MAAPP to all event participants and
- b. Detailed information for reporting protocols, including MAAPP violations.

Status: Completed before the deadline

Corrective Action Remediation Date: October 28, 2025

Audit Standard: Communication & Reporting

Deadline to Complete Corrective Action: September 4, 2025

Corrective Action:

U.S. Bowling Congress must communicate to all membership and Adult Participants the Center's most recent Code by email, newsletter, hard copy or other electronic medium. U.S. Bowling Congress must use the following language: "The USOPC, all NGBs and all LAOs must comply with the policies and procedures within the SafeSport Code."

Status: Completed before the deadline

Corrective Action Remediation Date: September 2, 2025

<u>Audit Standard:</u> Quality Control System

Deadline to Complete Corrective Action: September 4, 2025

Corrective Action:

U.S. Bowling Congress must ensure associations have access to the accurate Suspended Bowler list, to include all individuals who are ineligible to participate, including athletes who are banned, or suspended.

Status: Completed before the deadline

Corrective Action Remediation Date: September 2, 2025

Audit Standard: Quality Control System

Deadline to Complete Corrective Action: September 4, 2025

Corrective Action:

The U.S. Bowling Congress must develop a procedure to ensure adherence to organizational policies for events, programs, activities, or competitions that are authorized, organized, or under the oversight of the Organization by:

- a. Confirming acknowledgement of adherence to organizational policies when U. S. Bowling Congress staff are not on site.
- b. Explicit language in communication of procedures that adherence is required by U.S. Bowling Congress.

Status: Completed before the deadline

Corrective Action Remediation Date: September 2, 2025
